## 12 NURSES COMPLETE NEW ASSISTED LIVING NURSE LEADERSHIP PROGRAM

ALBANY, NY - The New York State Center for Assisted Living (NYSCAL) is pleased to announce that twelve nurses from assisted living facilities across New York State have completed the Foundation for Quality Care's Assisted Living Nurse Leadership Program. This innovative program was designed to enhance the quality of care and quality of life for residents and staff through the development of the nurse's leadership skills.

The Assisted Living Nurse Leadership Program is part of the Long Term Care Leadership Institute which was developed by the Foundation for Quality Care, a non-profit research and educational foundation affiliated with the New York State Center for Assisted Living. The course covered key topics including effective communication, conflict management and resolution, coach and mentoring skills and personcentered care. The program was funded through an educational grant received from the NYS Department of Health and the NYS Department of Labor Health Workforce Retraining Initiative.
