NAB's **CE Registry** is the perfect solution to help you

The NAB CE Registry is the first of its kind and will be free of charge to long term care licensees.

NABVerify will enable you to track both CE approved by NAB's National Continuing Education Review Service (NCERS) as well as non NCERS approved CE. Once your license is due, you simply release your registry to your state board/Agencies(s) electronically (please note that some states have mandatory electronic reporting systems that might still be required).

Signing up for a registry is easy. Individuals can simply visit <https://www.nabweb.org/manage-my-account>. If you do not currently have a NAB user account (which is different from your exam account) you will need to choose "Not a Member? Sign Up!" Once signing up for a NAB account, you will see a link to access your CE Registry.

Practitioner: Start Registry

NAB Verify offers a registry for tracking completed CE. In order for sponsor to add courses to your registry, we need to know state and license number of at least one of your licenses for which you are earning CE. You will need to give this information to the sponsor when you register for or attend that course as they can report your CE to the registry. You may also provide other related license information on the other tabs. This also sets for you license expire date and term length (in months) so we can organization your registry to match your term. All courses completed during a given licensing period will be grouped on the same registry.

Beginning April 1, 2018, all NAB approved NCERS providers will be required to report credit to the CE registry. If credit is reported directly to the registry, a certificate of course completion will be auto generated. Prior to mandatory reporting by NCERS providers, licensees will be able to manually enter your NCERS earned CEs into your record to assure a complete CE portfolio. The NAB approval code will be needed to enter the course manually. Administrators must register for NAB ID no later than April 1, 2018 to continue to receive CE certificates from NCERS sponsors.

NEW! – Licensees can now complete course evaluations directly within the CE Registry. Once a CE record has been added, simply click on the gear icon beside the program “Recorded” button and you will have an option to evaluate the programs you attended. This will provide a wealth of knowledge to NAB as we strive to continue to bring administrators quality long term care continuing education.
