His duties included performing safety and health inspections, accident investigations and enforcement. Mr. Donofrio has received the Secretary of Labor's Exceptional Achievement Award, was presented the Regional Administrator's Strong Enforcement award three times and is a four-time recipient of the Secretary's Honor Award for Worker Protection.

Currently, he conducts outreach, education, training, and relationship building to business groups, associations, unions, community, and religious groups to assist OSHA fulfilling one of its primary missions: compliance assistance.
