Ethics & Ethics Committees in Long-Term Care Facilities

Ethics in long-term care centers on protecting residents' dignity, rights, and well-being while balancing autonomy, safety, and fairness. Because issues like end-of-life decisions, consent, and resource allocation can be complex, ethics committees help by offering case reviews, policy guidance, and staff education. Creating such a committee requires a clear purpose, diverse membership, structured review processes, and strong confidentiality, all of which build trust and support ethical care. Dr. Battisti will lead an ongoing discussion and practicum on forming and operating an Ethics Committee.

Addressing Loneliness: A Social Revolution in Senior Living

SPEAKER: Kristine Theurer, PhD | Java Group Programs

Loneliness is affecting a majority of residents in senior living communities. The associated health risks are significant and include falls, premature mortality and poorer health, the progression of dementia, and disease outcomes such as cancer, stroke, and heart disease. Recreational programming often focuses on entertainment and distraction, rather than opportunities for meaningful resident engagement or contribution. There is no pill or vaccine for loneliness, but there is a cure and that is meaningful relationships. Residents represent a largely untapped resource - a social revolution - to address loneliness. This session will outline a research-based innovative model using peer support and peer mentoring. Research has demonstrated decreases in loneliness, depression and up to 60% increases in resident engagement. Attendees will be able to evaluate the research and this approach, experience a live peer support group and leave with a take-away strategy on how to implement peer support and mentoring within their organization.
